Keynote Presenter

Loren Andrews, MA, MSW, LCSW

Loren Andrews, MA, MSW, is a Licensed Clinical Social Worker with a private practice in Rockland, Maine. His practice specializes primarily in relational and couples counseling, adolescent and adult ADHD, anxiety and panic disorder, as well as helping victims of trauma in their recovery. As Adjunct Faculty at the University of Maine in the Masters program in Social Work, he has taught classes in Child and Adult Psychopathology, Clinical Interventions Across the Lifespan, Advanced Social Policy, Community-Based Interventions, and Social Administration. He also serves as Vice Chair of the RSU 13 School Board, chairs its Student Engagement Task Force, and is chair of the Maine NASW's Legislative Action Committee.

Morning Breakout – Session 1A

John Yasenchak, Ed.D., LCPC, LADC

John Yasenchak, Ed.D., LCPC, is Associate Professor in the Graduate Counseling and Human Relations Program, Husson University, Bangor Maine. He is also a Maine licensed clinical counselor, licensed substance abuse counselor, and certified clinical supervisor. For twenty years John served as clinical supervisor for the Penobscot Indian Nation Counseling Services and was adjunct assistant professor in counselor education at the University of Maine. In addition to his doctorate in counselor education, John also holds an MA in philosophy from Fordham University .He taught philosophy at Loyola University in Baltimore for several years and trained in both pastoral ministry. John is Past- President of the Maine Counseling Association and served as Chair for the North Atlantic Region of the American Counseling Association. He currently serves on the State of Maine Substance Abuse Services Commission and the board of the Co-occurring Collaborative Serving Maine. John has both taught courses and presented workshops on ethics, ethical decision making, and digital ethics.

Lori K. Gramlich, MSW, LMSW

Lori K. Gramlich, MSW, LMSW is a 1997 graduate from University of New England Masters School of Social Work. She has 30 years of experience in nonprofit prevention based social work, advocacy, and social justice. She has worked with the Maine Department of Health Human Services, served as Communications Director for Senate President Beverly Daggett in Maine State Legislature, and was elected to Portland School Committee in 1995 where she served on both the Policy and Finance Committees and was Chair of the Legislative Affairs Committee. Lori is adjunct faculty at the University of Southern Maine Social Work Department and is presently Executive Director of NASW ME Chapter.

Michael F. Brennan, M.A., MSW, LCSW, was the first popularly elected Mayor for the City of Portland in nearly nine decades. Prior to his election as mayor, Michael worked as a Policy Associate with the Cutler Institute of Child and family Policy at the Muskie School for Public Service, specializing in education and health. Michael also served as a State Representative from Portland for eight (8) years where he chaired the Education Committee and the Joint Select Committee on Substance Use. He served five (5) years in the State Senate where he chaired the Health and Human Services Committee and the Joint Select Committee on Health Care Reform. He also served as the Senate Majority leader. He currently teaches in the Social Work Departments at the University of Southern Maine and the University of New England. He works at Common Dreams, a nonprofit independent news service in Portland. Michael currently serves on Legislative Committees for the Maine Chapter, NASW and is the Chapter's president - elect.

Bobbi L. Johnson, LMSW

Bobbi Johnson is the Associate Director of Child Welfare Services for the Office of Child and Family Services within the Maine Department of Health and Human Services. She obtained her Master's degree in Social Work at the University of Maine at Orono and is a Licensed Master Social Worker. Bobbi has worked for OCFS for 22 years. In her role, she is responsible for the overall leadership and strategic direction of child welfare services in Maine.

Bobbi has experience with community building at both the local and statewide levels, and has been instrumental in moving the work of child welfare from an agency responsibility to the shared responsibility of families, OCFS and community partners. She has been active on several committees, including the Maine Child Welfare Advisory Panel, the Kinship Advisory Board and the Domestic Violence Homicide Review Panel. These efforts bring together partners statewide and are focused on improving the system of care, maximizing resources and promoting the voices of the individuals we serve.

Anne Head, Commissioner, Department of Professional and Financial Regulation

Anne L. Head of Yarmouth is the Commissioner of the Department of Professional and Financial Regulation. Her appointment was made by Governor Paul R. LePage on January 6, 2011. Anne continues to serve as Director of the Department's Office of Professional and Occupational Regulation, a position she has held since March 11, 1996. The Office of Professional and Occupational Regulation is a state agency responsible for protecting the public health, safety and welfare through the regulatory functions of professional and occupational licensing programs. Previously, Anne served as General Counsel of the Maine Health Care Finance Commission. She is a graduate of Ithaca College and Catholic University Law School. Prior to her service at the Maine Health Care Finance Commission, Anne served as legal counsel to the Federal Election Commission in Washington, D.C.

Cathleen Dunlap, LCSW

Cathleen Dunlap, M.Ed., MSW, LCSW, is Clinical Director at Paramount Behavioral Services, Inc., in Waterville, Maine. Prior to this very rewarding career, Ms. Dunlap worked for the University of Maine system and Kennebec Valley Community College (teaching and advising students), Southern Kennebec Child Development Corp. (Assistant Director), Sexual Assault Crisis and Support Center (supporting survivors of sexual assault), Maine Department of Labor Vocational Rehabilitation (counseling people who live with mental and physical disabilities), Family Violence Project (working with women who choose to stay with their abusive partners, then directing the Menswork program), and Togus Veterans Administration (working with veterans from conflicts in Iraq and Afghanistan).

Ms. Dunlap has lived in Maine all of her life and, in fact, traces ancestors to Augusta, Maine, prior to the Revolutionary War. Ms. Dunlap has been a member of Augusta's Bicentennial Committee, a statewide domestic violence coalition, the NASW Maine Chapter Board of Directors, and several mental health boards. Currently Cathleen Dunlap is Chair of the NASW Maine Continuing Education Committee and is a member of the chapter's Ethics Committee. An avid reader, Ms. Dunlap is currently involved in two book/reading clubs in central Maine.

Cathleen Dunlap has been married for over 45 years and has three children and four grandchildren. Cathleen Dunlap has dedicated herself to providing care and support to people who are scared, oppressed, abused, and/or unable to achieve their life's goals without assistance.

John J Campbell, MD, FANPA is the Chief Medical Informatics Officer and Medical Director of Community Services at Acadia Hospital. Prior to coming to Acadia Hospital, Dr. Campbell served as the Medical Director of General Hospital Psychiatry and Vice-Chairman of the Department of Psychiatry at Maine Medical Center. In addition, he was the Medical Director of Henry Ford Kingswood Hospital, part of the Henry Ford Health System in Detroit, MI. Dr. Campbell is a graduate of Brown University and attended the University of Vermont College of Medicine. He completed his residency training in psychiatry at Brown University and while there also completed a fellowship in neuropsychiatry.

Dr. Campbell has been a champion of affordable, high quality healthcare for many years. He is an advocate for patient-centered care and, in particular, has emphasized the design of behavioral health delivery systems capable of achieving the Quadruple Aim: Measurable improvements in community health, Delighting the customer, Making care affordable, and Keeping providers engaged. His clinical background is in providing psychiatric care to medically complex populations and he has been a leader in the psychiatric care for patients with dementia-related psychiatric complications for almost 20 years. Dr. Campbell currently serves as the President of the American Neuropsychiatric Association.

Joshua Bridges is a family nurse practitioner who works in the Mood and Memory Clinic at Acadia Hospital. Josh earned dual bachelor's degrees in Biology and Nursing in 2009 from the University of Maine. He completed training as a family nurse practitioner at Husson University in 2015 and is currently pursuing a post master's certificate as a psychiatric mental health nurse practitioner. Josh started his career at Acadia hospital in 2010 working as a registered nurse on the adult inpatient psychiatric unit. For the last five years he has worked in the outpatient Mood and Memory Clinic where he worked first as an RN and then as a nurse practitioner. Josh has a special interest in treating older adults with chronic mental health disorders and/or cognitive disorders. He has a father living with Alzheimer's disease and approaches his work from both evidence based research and personal experience.

Amy Cotton is EMHS Vice President for Patient Engagement and Chief Patient Experience Officer. She has more than 25 years clinical practice experience, including board certification as a family nurse practitioner in primary/community settings, certification in geriatric nursing and front line staff nursing experience in acute and home health care. Ms. Cotton is currently a doctoral student at Massachusetts General Hospital's Institute for Health Professions and is nationally certified as a Patient Experience Professional, Professional in Healthcare Quality and is a Lean Six Sigma Black Belt.

She was awarded Fellow status in the American Academy of Nursing and the recipient of Sigma Theta Tau International Honor Society of Nursing's Geriatric Nursing Leadership Award. She is the past president of the National Gerontological Nursing Association and currently volunteers on the American Academy of Nursing Expert Panel on Aging and for a non-profit in southern India providing education to home care workers on best clinical practice for care of older adults.
